DIRECTIONS FOR USE:

Application Rate: Apply at 150 to 200 kg per hectare.

Apply to dry turf or foliage and irrigate thoroughly immediately after application. Iron and other plants nutrients can cause staining of sidewalks. Sweep walkways prior to irrigation. Walkways should be dry at time of application. Keep away from pools, ponds, etc. Do not contaminate potable water. Do not apply with a drop-type spreader. The grinding action of these spreaders destroys the coating of the urea and will increase burn potential.

SPREADER SETTINGS: These suggested spreader settings are not intended to replace your normal calibrations. Calibrate your spreader before applying product.
