Section 4 - First Aid Measures

General Information: You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. The number is 13 1126 from anywhere in Australia and is available at all times. Have this MSDS with you when you call.

Inhalation: If exposed, remove victim to fresh air. Recovery is rapid after removal from exposure. Seek medical attention if irritation persists or breathing difficulties arise

Skin Contact: Remove contaminated clothing and wash thoroughly with soap and water. Seek medical attention if irritation develops. Launder clothing before reuse.

Eye Contact: Hold eye open and flush gently with copious amounts of water for 15 minutes. Seek medical attention if irritation develops.

Section 6 - Accidental Release Measures

Spillage: Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. Stop leak if safe to do so, and contain spill. Sweep up and shovel or collect recovered product into labelled containers for recycling or salvage, and dispose of promptly. After spills, wash area preventing runoff from entering drains. If a significant quantity of material enters drains, advise emergency services. This material may be suitable for approved landfill. Ensure legality of disposal by consulting regulations prior to disposal. Thoroughly launder protective clothing before storage or re-use. Advise laundry of nature of contamination when sending contaminated clothing to laundry.

Section 7 - Handling and Storage

Handling: Before use carefully read the product label. Use of safe work practices are recommended to avoid eye or skin contact and inhalation. Observe good personal hygiene, including washing hands before eating. Prohibit eating, drinking and smoking in contaminated areas.

Storage: Store in cool, dry, well ventilated area removed from combustible materials, herbicides, fungicides and foodstuffs. Do not allow to come into contact with water either from rain, condensation or the surface on which it is stored. Ensure containers are labelled, protected from physical damage and sealed when not in use. Keep from extreme heat and open flames and make sure that the product does not come into contact with substances listed under "Materials to avoid" in Section 10. Bagged fertilisers should be stored under cover and out of direct sunlight

Section 8 - Exposure Controls and Personal Protection

The following Australian Standards will provide general advice regarding safety clothing and equipment:

Exposure limits have not been set for any ingredients in product. The STEL (Short Term Exposure Limit) is an exposure value that should not be exceeded for more than 15 minutes and should not be repeated for more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The exposure value at the TWA is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. A TWA has not been established by Worksafe Australia for any of the major ingredients in this product. There is a blanket limit of 10mg/m³ for dusts or mists when limits have not otherwise been established. The nature of this product makes it unlikely that this level will be approached in normal use. ADI means Acceptable Daily Intake and NOEL means No-observable-effect-level. Values taken from Australian ADI List, Dec 2003.

Ventilation: Avoid high dust concentration and provide local exhaust ventilation where necessary.

Eye Protection: Eye protection such as protective glasses or goggles is recommended when using this product.

Skin Protection: Wear gloves or gauntlets and long sleeves when using this product to protect against skin irritation

Respirator: Use P2 type canister respirator where high concentrations of airborne dust is present

Provision of eye wash facilities and safety shower recommended.

Wash hands before eating, drinking, smoking or going to toilet, launder protective clothing before re-use.

Section 10 - Stability and Reactivity

Section 12 - Ecological Information

Environment: Avoid contamination of waterways. Fertilisers, particularly those containing nitrogen and phosphorus can stimulate weed and algal growth in static surface waters. Nitrogen fertilisers can also contain or form Nitrate which can contaminate surface and ground water. High nitrate concentrations may render the water unsuitable for human and livestock consumption.

Ecotoxicity effects: Dissolves slowly in water. Harmful to aquatic life

Persistence/degradation: Will persist for weeks in soil, but is a plant nutrient.

Section 13 - Disposal Considerations

Disposal: There are many pieces of legislation covering waste disposal and they differ in each state and territory, so each user must refer to laws operating in their area. In some areas, certain wastes must be tracked.
